INFORMATION FOR NON-PRACTISING REGISTRATION

Section 7A of the VPA provides for non-practising registration

Practitioners may apply for non-practising registration at the time of retiring or withdrawing from practising if working in a totally non veterinary occupation or for parental leave, carers leave or travel purposes. Conditions apply to holding non-practising registration in Victoria such as being unable to carry out veterinary procedures; provide veterinary services (even treatment of own animals); purchase, possess or supply scheduled drugs under the Drugs and Poisons legislation; and exercise authority requiring registration as a veterinary practitioner. Non-practising registrants remain on the public Register.

Note: only applicants who hold general registration in Victoria are eligible to apply.

Conditions on non-practising registration

Non-practising registration carries the following conditions:

- may not carry out veterinary procedures including treatment of own animals in Victoria
- may not provide veterinary services in Victoria
- may not purchase, possess or supply scheduled drugs under the Drugs, Poisons and Controlled Substances legislation in Victoria
- may not exercise authority requiring registration as a veterinary practitioner in Victoria.

The Register

Veterinary practitioners holding non-practising registration will be listed separately on the veterinary Register and will appear on the website as non-practising

Specialist Endorsement

Veterinary practitioners who hold endorsement as a specialist under section 8 of the Veterinary Practice Act 1997 and who are granted non-practising registration may describe themselves as 'registered specialist non-practising' but may not offer any level of veterinary procedure or veterinary services in Victoria – general or specialist. This includes the provision of specialist consulting services.

Registration Period

Non-practising registration is granted on an annual basis and must be renewed each year.

Complete the attached form and return with payment to the Veterinary Practitioners Registration Board of Victoria, Level 11, 470 Collins St Melbourne 3000.

Note: the Board does not accept applications by email or facsimile.

EVIDENCE (MISCELLANEOUS PROVISIONS) ACT 1958 STATUTORY DECLARATIONS

107 Statutory declarations

(1) A statutory declaration must —

- (a) contain an acknowledgement that it is true and correct and is made in the belief that a person making a false declaration is liable to the penalties of perjury; and
- (b) be signed by the person making it in the presence of a person who is authorised under Section 107A (1) to witness the signing of a statutory declaration

(2) A person who makes a declaration which the person knows to be false is liable to the penalties of perjury.

107A List of persons who may witness statutory declarations

(1) Any of the following persons may witness the signing of statutory declaration:

- (a) a justice of the peace or a bail justice;
- (b) a public notary;
- (c) an Australian lawyer (within the meaning of the Legal Profession Act 2004);
- (d) a clerk to an Australian lawyer;
- (e) the prothonotary or a deputy prothonotary of the Supreme Court, the registrar or a deputy registrar of the County Court, the principal registrar of the Magistrates' Court or a registrar or deputy registrar of the Magistrates' Court;
- (f) the registrar of probates or an assistant registrar of probates;
- (g) the associate to a judge of the Supreme Court or of the County Court;
- (h) the associate of an Associate Judge of the Supreme Court or of an associate judge of the County Court;
- (i) a person registered as a patent attorney under Chapter 20 of the Patents Act 1990 of the Commonwealth;
- (j) a member of the police force;
- (k) the sheriff or a deputy sheriff;
- (l) a member or former member of either House of the Parliament of Victoria;
- (m) a member or former member of either House of the Parliament of the Commonwealth;
- (n) a councillor of a municipality;
- (o) a senior officer of a Council as defined in the Local Government Act 1989;
- (p) a person registered under the Health Practitioner Regulation National Law to practise in the medical profession (other than as a student);
- (q) a person registered under the Health Practitioner Regulation National Law—
 - (i) to practise in the dental profession as a dentist (other than as a student); and
 - (ii) in the dentists division of that profession;
- (r) a veterinary practitioner;
- (s) a person registered under the Health Practitioner Regulation National Law to practise in the pharmacy profession (other than as a student) ;
- (t) a principal in the teaching service;
- (u) the manager of an authorised deposit-taking institution;
- (v) a member of the Institute of Chartered Accountants in Australia or the Australian Society of Accountants or the National Institute of Accountants;
- (w) the secretary of a building society;
- (x) a minister of religion authorised to celebrate marriages;
- (y) a person employed under Part 3 of the Public Administration Act 2004 with a classification that is prescribed as a classification to which this section applies or who holds office in a statutory authority with such a classification;
- (z) a fellow of the Institute of Legal Executives (Victoria).
